# Matters of Special Order.

a. Recommendation of Finance Committee- Dr. Kevin Abraham proposed the increase below for the board's approval in preparation for the FY26 Budget.

1) Tuition	Current	Proposed	Increase
Part-time (1 – 14 hours per credit)	\$150	\$165	\$15 (10%)

Anticipated Revenue generated - \$127,802.49

Federal Pell awards packages have increased in FY21, FY22, FY23, FY24, and FY25.

2) Fees	Current	Proposed	Increase
Registration Fee	\$125	\$150	\$25 (20%)

Anticipated Revenue generated - \$354,286.05

FY26 Total Anticipated Revenue increase - \$482,088.54

Upon recommendation from the Finance Committee, the board voted unanimously to approve the Tuition and Fees Increase for the FY26 Proposed Budget. A copy is on file and included in the minutes of the meeting.

b. Unreceived Donation of Obsolescent Parts totaling \$ 251,913.62- Dr. Parker shared that last month, the board approved the donation of obsolescent parts from Hallmark Hyundai North Ridgeland and Hallmark Hyundai of Flowood. Initially, Hallmark Hyundai North Ridgeland and Hallmark Hyundai of Flowood did not want a tax deduction for the donation. Hallmark Hyundai North Ridgeland and Hallmark Hyundai of Flowood would now like to receive a tax letter for the donation; therefore, the board will vote to unreceive the donation, and Hinds Community College Foundation will handle the donation from Hallmark Hyundai North Ridgeland and Hallmark Hyundai of Flowood and give the proper paperwork for the donation.
